

2022-2023 Expenditures






Where Does Each Dollar We Spend Go?

Tax Levy Limit

- Tax Levy Limit Calculation shows allowable 2.73% increase or \$378,967
- Tax Levy increase = 0%
- Every 1% tax levy increase equals \$138,881 additional revenue

The Olean City school district directly employs about 378 people. The district's purchase of goods and services as well as employee personal spending is responsible for about 246 additional spillover jobs in the Western Region region. The school district is responsible for a total of about 625 jobs. These jobs generate \$32.7 million in income. \$20.4 million is directly connected to Olean City employees. Another \$12.2 million is generated by spillover spending that generate additional jobs. This income generates an estimated \$1.6 million in state income tax in total and \$1 million in sales tax.

School Board Member Election

The election of members of the Board of Education shall be held to fill three (3) at-large positions on the Board, created by the expiration of the terms of Janine Fodor and Paul Hessney, as well as to fill the vacancy created by the resignation of Frank Steffen, Jr., which was temporarily filled by the appointment of Tyrone Hall. The two candidates who receive the most votes will be elected to five (5) year terms commencing on July 1, 2022, and terminating on June 30, 2027. The candidate who receives the third-highest number of votes will serve immediately after the election (upon filing the oath of office) until June 30, 2024.
