WHEREAS, Mr. Pancio has filed a tax assessment challenge requesting a reduction in assessment to \$200,000;

WHEREAS, Mr. Pancio purchased the subject property which was formerly known as "Boardmanville Elementary School" from the Olean City School District in 2013 for the sum of \$251,101;

WHEREAS, the purchase was after the submission of competitive bids at a public auction conducted by the Olean City School District;

WHEREAS, the case law in New York provides that a recent arms-length transaction of the same property is generally binding as to the property value;

WHEREAS, a settlement of the assessment challenge has been proposed in which the 2015-2016 assessment will be reduced to \$238,500 (equalized fair market value of \$251,100) and the property owner will receive a refund of taxes based upon this reduction;

WHEREAS, should the property be redeveloped or improved in the future, the City Assessor would have authority to increase the assessment at that time;

WHEREAS, the City Assessor and the Olean City School District's legal counsel recommend approval of the proposed settlement; and

WHEREAS, the proposed settlement will save the District additional legal and appraisal costs and avoid potential tax refunds going forward in future tax years, it is hereby;

RESOLVED, that the proposed settlement authorizing the reduction in assessment from \$1,076,500 to \$238,500 (equalized fair market value of \$251,100) for the 2015-2016 tax year and authorizing the payment of a tax refund with statutory interest based upon this reduction is hereby approved.
