WHEREAS, the subject property was assessed by the City Assessor at an assessed value of \$4,300,000 for the 2015-2016 tax year;

WHEREAS, K-Mart has filed a tax assessment challenge requesting a reduction in assessment to \$860,000 and a tax refund for the 2015-2016 tax year;

WHEREAS, the property has been inspected by the City Assessor and the property is in need of upgrading and improvements;

WHEREAS, a settlement of the tax assessment has been proposed in which K-Mart will withdraw and discontinue the 2015-2016 proceeding, the assessment will be reduced from \$4,300,000 to \$4,100,000 for the 2016-2017, 2017-2018, 2018-2019, and 2019-2020 tax years and K-Mart will waive any tax refund from the City and School District;

WHEREAS, the City Assessor supports the proposed settlement;

WHEREAS, the settlement will save significant litigation and appraisal costs and potential tax refunds for the current and future years; and
