- **A. Rural Schools Event:** Dr. Morris was a guest panelist at this event where several state-level personnel and high education representatives discussed how to recruit and retain teachers and develop a great workforce of teachers.

- **C. National Honor Society Breakfast:** Dr. Morris shared Scott Rucinski's (NHS Advisor) update on new members, NHS requirements, and she offered Congratulations to all new members.
- **D. NY Inspires A Plan to Transform Education in New York State:** Board of Regent's did a conclusive meeting adopting new transformations to education in New York State. Dr. Morris shared the four points that New York State is proposing and the District awaits further advisement from NYSED. She shared the timeline that is to be followed, with full implementation expected by Fall of 2029.
- E. Swatting Event of October 31, 2024: Dr. Morris addressed the 10-31-24 event in the district.
 - A swatting attack is a deliberate and malicious act of someone reporting a false claim harassing or menacing the district (or target).
 - Local law enforcement for swift response (within 2 minutes) and district teams who were responsible and effective.
 - · School safety plan and protocols worked as intended.
 - Dr. Morris warned that several students had their cell phones and in a true lockdown event, the use of cell phones can endanger the person with the phone or others around them. We are collecting feedback and sharing the information that cell phones should not be used during a true emergency.
