- 2. "It's too hot to have school" policy
- This items will be a Building Condition Survey (BCS) topic; especially OIMS
- School Law addresses temperature of classrooms during the colder months (no lower than 65 degrees)
- School Law does not address temperature of classrooms during hotter weather
- Superintendent at their discretion can close schools due to extreme hot or cold temperatures
- If an employee feels their room is too hot or cold, they should reach out to the building principal; maintenance will be able to check the temperature and perhaps make adjustments
- 3. Pool Filtration System Update
- Jenny noted the district is in need of doing an emergency project; will place a resolution on the December 12th BOE agenda
- System that feeds chemicals into the pool is broken; pool is now closed
- Will take approximately two weeks to get the equipment and two weeks to install the equipment
